1. Deb Wagner is in the process of writing a security grant.

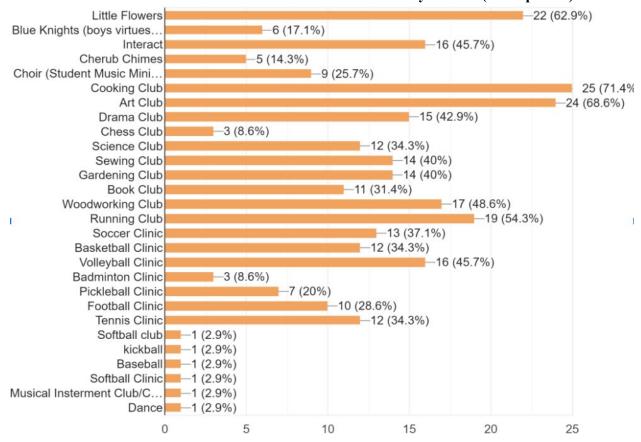
e. 10% Enrichment - \$3,424.38

1. Nothing has been spent so far. Perhaps we could use it for Bricks4Kids or cooking club.

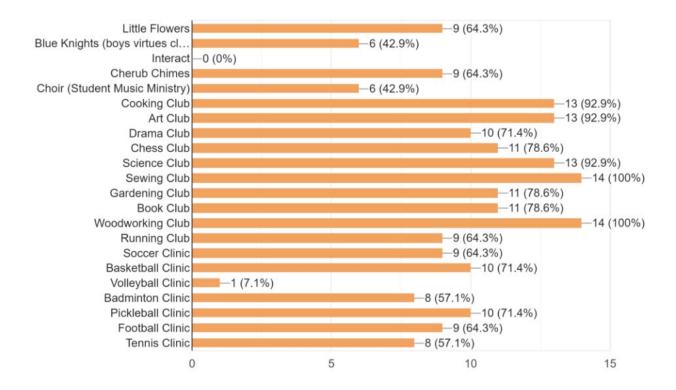
ii. Parents and students were surveyed as to their enrichment opportunities for the 2023-2024 school year
